### The Carob Tree

A Talmudic story tells of a traveler who once saw an older man planting a carob tree. The traveler asked when the tree would bear fruit.

"After seventy years" was the reply.

"Dost thou expect to live seventy years and eat the fruit of thy labor?"

"I did not find the world desolate when I entered it," said the man, "and as my ancestors planted for me before I was born, so do I plant for those who will come after me."



## How to Create a JFCS Carob Tree Named Endowment Fund

- 1. Select a Purpose:** Consider whether you would like your fund to support academic scholarships, Holocaust education, emergency services, where it is most needed, or a favorite program, such as services for children or seniors.
- 2. Choose a Name:** Name the fund in honor of a family member or friend, in memory of a loved one, or in your own name, as a statement of your personal values and commitment. Or use the fund name to commemorate a milestone, like a marriage or the birth of a child or grandchild.
- 3. Complete a Simple Named Endowment Fund Agreement:** We will prepare an agreement that reflects your wishes.
- 4. Fund Your Endowment:** Make a \$10,000 commitment, payable over four years, and earn a \$3,600 Carob Tree match to more quickly build your fund's impact.

A gift of \$2,500 can establish a fund in honor of a bar or bat mitzvah or in memory of a loved one.

Many supporters find it beneficial to use long-term appreciated stock shares or a charitable distribution from an individual retirement account (IRA) to make their gift.

Another popular option is to create a Named Endowment Fund today and have a future bequest flow into the fund.
